

Perry Township Board of Supervisors
February 10, 2011 Regular Meeting Minutes

The Perry Township Board of Supervisors held their regular meeting at 6:00 p.m. on Thursday, February 10, 2011 at the Perry Township Municipal Building. Supervisors in attendance were: John Zias and Tim Boots. Dori McElwain was absent. Solicitor Greg Fox and Secretary/Treasurer, Janice Marshall and 6 visitors were present.

Chairman John Zias called the meeting to order beginning with the Pledge of Allegiance. Visitor's comments: Sam Pawlowski-good winter maintenance; David Marks - possible upcoming change for Pleasant Hill Baptist Church.

Zias motioned and Boots second to accept the minutes of the January 3, 2011 meeting. Motion passed with all in favor. Boots motioned and Zias second to accept the treasurers report and pay the bills. Motion passed with all in favor. The Roadmaster and Tax collector and permit reports were presented. It was announced that Dorothy Wallace has resumed her duties as tax collector effective February 1, 2011.

Boots motioned and Zias second to advertise the Lawrence County/Perry Township Stormwater Maintenance Ordinance for adoption at the March 10, 2011 regular meeting. Motion passed with all in favor.

Boots motioned and Zias second to submit the bid request for summer products to the Lawrence County Regional COG for bidding and awards and that the Roadmaster shall determine the products and quantities to bid/submit. Motion passed with all in favor.

Boots motioned and Zias second to approve the winter salt agreement with COSTARS for the 2011-12 winters season with the quantity of salt to be 225 tons. Motion passed with all in favor.

Any action on the flood plain ordinance was tabled until the next meeting.

Residents were reminded of the County Outreach Program for payment of county taxes that will be held at the township building on March 31 from 9-12:00.

Communication was received from the Perry Township Auditors that the compensation for working Supervisors was set at \$14.00 for the Roadmaster and \$12.50 for part-time working Supervisor.

Boots motioned and Zias second to approve a business membership with Costco at the rate of \$50.00 per year to be used for supplies and to approve the application for a Costco American Express credit card to be used for the purchase of supplies with the limit of \$1000 to be requested. Motion passed with all in favor.

Boots motioned and Zias second to allot \$150.00 to each road laborer employee per year toward the purchase of work boots. Boots are to be purchased and reimbursement will be made after the township receives the receipt. Motion passed with all in favor.

Zias motioned and Boots second to purchase a used Gantry crane for the shop for \$1800. Motion passed with all in favor.

Zias motioned and Boots second to purchase a 16 foot Step Ladder for the shop for \$400. Motion passed with all in favor.
