

Perry Township Board of Supervisors
March 11, 2021 Regular Meeting Minutes

The Perry Township Board of Supervisors held their regular meeting at 4:00 p.m. on Thursday, March 11, 2021 at the Perry Township Municipal Building. Supervisors in attendance were: John Zias and Tim Boots. James Radich. Secretary/Treasurer Janice Marshall, one visitor were present.

Vice-Chairman Tim Boots called the meeting to order beginning with the Pledge of Allegiance. Visitor's comments: Sam Pawlowski-the township rollers

Zias motioned and Radich second to accept the minutes of the February 11, 2021 meeting. Motion passed with all in favor. Zias motioned and Radich second to accept the treasurer's report and pay the bills. Motion passed with all in favor.

The Roadmaster, Tim Boots discussed the summer road projects: Lesnett Road, Nye Road, Levis Road, work to include taking care of soft spots and seal coating the roads.

Boots discussed the situation with changes to Sewage Permit Applications and approvals. A letter is to be sent to Aaron Bernstein for support to oppose the changes.

Boots to get the information to the Secretary to apply for the County Grant for Lesnett Road work before March 15th.

Boots motioned and Radich second to pass Resolution 3-11-21 Adoption of the Lawrence County 2021 Hazard Mitigation Plan. Motion passed with all in favor.

The Lawrence County Tax Outreach Day will be held at the Perry Township Municipal Building on March 24 from 10:00-12:00 for the payment of 2021 Lawrence County Taxes.

Boots motioned and Zias second to make a donation of \$50.00 for a door prize at the May 19th Lawrence County Township Convention. Motion passed with all in favor.

The Supervisors received a response from Aaron Bernstein about a complaint about the road repairs on Portersville Road by Lookout Avenue.

May 1st was set for the Perry Township Annual Clean-up Day. Fees of \$10 and \$50 per load is to be charged.

Boots motioned and Zias second to donate \$100.00 toward the Ellwood City Area Easter Egg Fund Drive. Motion passed with all in favor.

Zias motioned and Boots second to adopt the revised Employee Manual. Motion passed with all in favor.

Boots motioned and Radich second to pass Resolution 3-11-21-2 to approve the County Exonerations of Road Tax Record Changes received prior to and including the March 3, 2021 notice from the County Assessment Office and to accept approvals completed from this date on by motions by the Supervisors at their regular meetings. Motion passed with all in favor.

The Summer Bid Products have been advertised and will be awarded at the April meeting.

Boots motioned and Zias second to pay off the F550 Lease. Motion passed with all in favor. Marshall to check to make sure no penalties for paying off early.

Radich motioned and Boots second to purchase with a lease contract, a JCB 110 EW Dig All and authorize Boots and Marshall to be the authorized signers. Motion passed with all in favor. The Supervisors and road crew are to go to Stephenson Equipment for a demo.

Boots motioned and Radich second to adjourn. Motion passed.
