

Perry Township Board of Supervisors
December 8, 2022 Regular Meeting Minutes

The Perry Township Board of Supervisors held their regular meeting at 4:00 p.m. on Thursday, December 8, 2022 at the Perry Township Municipal Building. Supervisors in attendance were: James Radich and Tim Boots. Secretary/Treasurer Janice Marshall; Brandie Massioni Secretary/ Treasurer to be in January and Solicitor Thomas Smith were present. Two visitor were present.

Vice-Chairman Tim Boots called the meeting to order beginning with the Pledge of Allegiance. Visitor's comments: Fred Schuster – discuss status of grant for demolition of 710 Tara Drive.

Radich motioned and Boots second to approve the meeting agenda. Motion passed. Radich motioned and Boots second to accept the minutes of the November 10, 2022 meeting. Motion passed.

It is noted that an executive session was held at the conclusion of the budget workshop for personnel issues. The budget workshop was held at 4:00 p.m. on November 10, 2022. Boots motioned and Radich second to accept the treasurer's report and pay the bills. Motioned passed both in favor.

The Roadmaster and Permit reports were presented.

Boots motioned and Radich second to pass resolutions for 2023 Tax Levy for Perry Township taxes. Taxes set for General Fund Tax 1.79 millage; Water Tax .29 millage; Fire Apparatus Tax .5 millage, and Light Tax .12 cents for undeveloped property frontage and .48 cents per developed property frontage; Per Capita Tax at \$5.00 per person 18 and over. No changes in property tax. Motion passed.

Boots motioned and Radich second to pass resolution for the 2023 Budget Funds Appropriation for 2023 year. Motion passed.

Radich motioned and Boots second to set the Perry Township Reorganization Meeting for Tuesday January 3, 2023 at 4:00 p.m. and to advertise the Perry Township Board of Supervisors and the Auditor reorganization meeting. Auditor required for January 4, 2023 to confirm date and time before advertising. Motion passed.

Boots motioned and Radich second to make the budgeted donation to Wurtemberg Perry Twp. VFD in amount of 6,000. Motion passed.

Radich motioned and Boots second to transfer \$5,000 for the Capital Reserve Fund from the General Fund Account into township savings account until the Capital Reserve Fund CD renews. Motion passed.

Boots motioned and Radich second to pass Resolutions # 12-8-22-3; # 12-8-22-4; # 12-8-22-5; # 12-8-22-6 for Berkheimer to handle and collect Perry Twp. Per Capita Tax fees for 2023 year. Motion passed.

Radich motioned and Boots second to begin procedure to purchase a 2023/2024 F550 truck through Costar/Stephenson. Motion passed.

Radich motioned and Boots second to take out a 24 month CD at Wesbanco for Street Light Fund instead of annuity as discussed prior. Motion Passed.

Discussion of demolition of 710 Tara Drive is still on hold due to needing of 2 more bids.

Discussion of monthly electric bill going to over \$600. Boots to check into.

Appointment of Municipal Authority board members is still on hold until reorganization meeting in January. Perry Township Authority Members and their appointed five year terms are: Lynn LeViere-12/31/2026; Brian Bush-12/31/2025; Tom Hines-12/31/2024; Ron Cowan-12/31/2023; Ron Miller- 12/31/2022.

Boots motioned and Radich second to advertise to sell the International Truck.

Motion passed.

Boots motioned and Radich second to allow Josh Ottaviani- Emergency Management Administrator to be able to put EMC information on the township website. Motion passed.

Radich motioned to adjourn the meeting and Boots Second. Motion passed.
