

Perry Township Board of Supervisors
November 9, 2023 Regular Meeting Minutes

The Perry Township Board of Supervisors held their regular meeting at 4:00 p.m. on Thursday, November 9, 2023 at the Perry Township Municipal Building. Supervisors in attendance were: Tim Boots and James Radich. Secretary/Treasurer Brandie Massioni; and Solicitor Thomas Smith were present. Nine visitors were present

Vice-Chairman Tim Boots called the meeting to order beginning with the Pledge of Allegiance. Visitor's comments: Sam Pawlowski – grader; Fred Schuster and Jeffrey Markle – thanked township for efforts with tall grass and weeds; Patti Marshall and Dave Burns-chickens and animals, Karen Parsons-weeds on Bauder Mill Road.

Tim Boots motioned and James Radich second to approve the meeting agenda. Motion passed with both in favor.

James Radich motioned and Tim Boots second to accept the minutes of the October 12, 2023 meeting. Motion passed with both in favor. The budget workshop was held at 4:00 p.m. on Monday October 23, 2023 with all three supervisors present.

James Radich motioned and Tim Boots second to accept the treasurer's report and pay the bills. Motion passed with both in favor.

The Roadmaster and Permit reports were presented. Michael Rossi-Building Permit-Agricultural Pole Building, William and Gretchen Holcomb- Building New House.

James Radich motioned and Tim Boots second to advertise the 2024 budget for adoption at the December 14th meeting. Motion passed with both in favor.

James Radich motioned and Tim Boots second to pass Resolution 11-9-23 Appointment of the outside audit firm, Herrmann & Loll to complete the 2023 financial audit of the township and tax collectors' financials. Motion passed with both in favor.

Tim Boots motioned and James Radich second to have Thomas Smith stay on as the township Solicitor for the 2024 year. Motion passed with both in favor.

Update on Armstrong Cable Franchise Renewal Agreement with Cohen Law Group negotiating for the township. The renewal agreement is still in negotiation stages.

Discussion on the citation hearings on October 26, 2023 with the Lawrence County Magistrates office on Tall Grass and Weeds Ordinance 4-13-23 violations for properties; 224 Reno Road, and 705 Tara Drive.

Annual Donation was made out of the American Rescue Fund to the WPVFD.

Tax Collector reminder to residents that all taxes are to be paid by December 31st 2023.

Any taxes paid after December 15, 2023 will require a business check no personal checks will be accepted after that date.
