

Perry Township Board of Supervisors  
December 14, 2023 Regular Meeting Minutes

The Perry Township Board of Supervisors held their regular meeting at 4:00 p.m. on Thursday, December 14, 2023 at the Perry Township Municipal Building. Supervisors in attendance were: John Zias, Tim Boots, and James Radich. Secretary/Treasurer; Brandie Massioni and Solicitor Thomas Smith were present. Six visitors were present.

Chairman John Zias called the meeting to order beginning with the Pledge of Allegiance. Visitor's comments: Samuel Pawlowski-grader, Lynn LeViere-Armstrong Cable Agreement, Barbara Magee-Recycling, and Armstrong cable services.

John Zias motioned and Tim Boots second to approve the meeting agenda. Motion passed.

John Zias motioned and Tim Boots second to accept the minutes of the November 9, 2023 meeting. Motion passed.

Tim Boots motioned and James Radich second to accept the treasurer's report and pay the bills. Motioned passed.

The township taxes collected for months of September-October 2023, total for both months \$20,185.75

The Roadmaster and Permit reports were presented. Donald Rutter-House Demolition on Mecklem Lane, & Tracey Moser-Trailer Permit.

John Zias motioned and Tim Boots second to pass resolution 12-14-23-1 for 2024 Tax Levy for Perry Township taxes. Taxes set for General Fund Tax 1.79 millage; Water Tax .29 millage; Fire Apparatus Tax .5 millage, and Light Tax .12 cents for undeveloped property frontage and .48 cents per developed property frontage; Per Capita Tax at \$5.00 per person 18 and over. No changes in property tax. Motion passed.

Tim Boots motioned and James Radich second to pass resolution 12-14-23-2 for the 2024 Budget Funds Appropriation for 2024 year. Motion passed.

Tim Boots motioned and John Zias second to set the Perry Township Reorganization Meeting for Tuesday January 2, 2024 at 4:00 p.m. and to advertise the Perry Township Board of Supervisors and the Auditor reorganization meeting. Auditor required for January 6, 2024 to confirm date and time before advertising. Motion passed.

Liquid Fuels Grant \$30,000 for the purchase of a 2023 Ford F-550 truck was encumbered to the 2024 year with Lawrence County.

Armstrong franchise cable agreement renewal of services for the township still remains in negotiation stages with Armstrong. Cohen Law group is representing the township in negotiation steps.

Appointment of Municipal Authority board members is still on hold until reorganization meeting in January. Perry Township Authority Members and their appointed five year terms are: Lynn LeViere-12/31/2026; Brian Bush-12/31/2025; Tom Hines-12/31/2024; Ron Cowan-12/31/2023; Ron Miller- 12/31/2027.

John Zias motioned to adjourn the meeting and Tim Boots Second. Motion passed.
